Regular School Board Meeting

The Pledge of Allegiance was recited by all in attendance.

Mr. Mike Metzger, *School Board President*, called the School Board Meeting to order at 7:30 p.m. Present were Mr. Mike Metzger, Mr. Brian Ford, Mr. Chris Zaborowsky, Mr. Jack Napier and Mrs. Deanna Burton. A quorum was met.

A moment of silence was made for the loss of a Greenwood High School student.

The minutes of the regular school board meeting held February 16, 2021, the regular and prepaid vouchers, and personnel report were approved upon a motion by Mr. Ford and seconded by Mr. Zaborowsky. (5 yeas, 0 nays)

Deanna Burton, *ISBA Liaison for Greenwood School Board*, requested the approval of board resolution opposing House Bill 1005 and Senate Bill 413. A motion to approve was made by Mr. Zaborowsky and seconded by Mr. Ford. (5 yeas, 0 nays)

Dr. DeKoninck, *Superintendent*, recommended approval for overnight/out of state fieldtrips as presented. A motion to approve was made by Mr. Ford and seconded by Mrs. Burton. (5 yeas, 0 nays)

Dr. DeKoninck, *Superintendent*, requested board approval of summer camps and clinics with the understanding that adjustments could be made due to Covid precautions. The board approved upon a motion by Mr. Zaborowsky and seconded by Mr. Napier. (5 yeas, 0 nays)

Dr. DeKoninck, *Superintendent*, requested board approval of an amendment to the 2020/21 school calendar to add two additional remote learning days on 4/14 and 5/12. A motion to approve was made by Mr. Ford and seconded by Mrs. Burton.

Mr. Pritchett, *Assistant Superintendent*, requested the boards permission to advertise bids for summer projects if any work will be more than \$150k. Mr. Pritchett expressed that he believes this will not be necessary but wanted the approval just in case. A brief discussion took place. The motion to approve was made by Mr. Zaborowsky. The motion was seconded by Mr. Ford. (5 yeas, 0 nays)

Mr. Pritchett, *Assistant Superintendent*, requested approval to advertise for an online auction for surplus equipment. Mr. Pritchett explained that there is equipment in the metal shop that hasn't been used in several years. The high school would like to utilize that space in a better way. A brief discussion about the equipment took place before the motion to approve was made by Mrs. Burton. The motion was seconded by Mr. Ford. (5 yeas, 0 nays)

*Reports:*

Mr. Zaborowsky, *Central Nine Representative Alternate*, updated the board on the building project and budget. He also explained House Bill 1001, which is looking to cut certain programs, and how C-9 is responding to it. Greenwood Community High School had five students named as C-9 Student of the Month for March. They were: Alexandria Uebersetzig for *Cosmetology*, Helen Hurley for *Culinary Arts*, Cameron Beath for *Health Science I*, Vylaree Dang for *Health Science II* and Anderson Sluder for *Visual Communication*.

Mrs. Cooper, Director of Technology, had no formal report.

Mr. Hildebrand, *Director of Operations*, recognized Jim Burkhead and Bobby Foster for their exemplary work prior to the bus inspection. Greenwood Schools again had a 100% pass rating on all 47 buses.



Mrs. Harkness, *Director of Curriculum, Instruction & Assessment*, had no formal report.



Mrs. Jill Lambert, *Director of Student Services*, had no formal report.

Dr. DeKoninck, *Superintendent*, notified the board: 1) Spring Break is March 22-April 2, 2021. School will resume April 5. 2) We have not formally been given the application for Esser 2, which is federal relief grant money. We will be getting about 1.5 million dollars from that grant. Esser 3 was also just approved. That may bring three times the amount of money from Esser 2. Hoping by the end of the calendar year. 3) He thanked the board for their support with HB 1005 and SB 413. 4) He gave an update on C-9 and the budget with their building project and how it will affect Greenwood Schools financially.
